

**RULES AND REGULATIONS
FOR THE USE OF PINEVIEW WATER
ADOPTED BY THE BOARD OF TRUSTEES OF THE
SOUTH OGDEN AND WEBER-BOX ELDER CONSERVATION DISTRICTS**

The Irrigation District's Law (73-7-11 U.C. A. 1953 as amended) provides that the Board shall establish equitable rules and regulations for the distribution and use of water among the owner of lands included in the District. The contract between South Ogden Conservation District, the Ogden River Water Users' Association, and the United States of America; and the Weber-Box Elder Conservation District, the Ogden River Water Users' Association, and the United States of America requires that the basis, the measure, and the limit of the right of the districts to use water shall rest perpetually in the beneficial application of the same, in accordance with the law.

1. Watering time:

- a. Watering between the hours of 10:00 a.m. to 6:00 p.m. is prohibited.
- b. There will be no restrictions pertaining to the days on which watering may occur unless such is required due to drought conditions.

2. Do not waste water.

- a. Water should not be left running unattended. Shut the water off if no one is to be at home to watch it.
- b. Your lot has a definite amount of water allotted to it according to size. This is adequate if not wasted.
- c. Find out your water requirements: don't damage your lawn by over-irrigation. Too much water damages the lawn and leaches out desirable minerals needed for healthy lawns.
Many times a yellow lawn needs fertilizer rather than more water.
Two times a week is adequate for almost all lawns.
- d. Rainbirds and sprinkler heads should be adjusted so water will not get into streets, gutters, or adjacent properties.
- e. Water should not be allowed to run so long in one place causing the ground to become so saturated that the water runs off the lawn into the gutter and streets or adjacent properties.
- f. Fix leaky valves and broken pipelines. Water running continually from a leaky valve or cracked pipe wastes water and could cause damage.
- g. We recommend that nozzles be used on hoses in sprinkling lawns.

3. Service charges by district.

- a. When water users neglectfully leave their valves open at any time water is in the system such that District personnel are required to turn them off to prevent damage or waste of water, a service charge of \$50 will be made by the District. Any negligent operation by a water user, that requires a service call by District personnel, will be charged \$50 per service call.

4. Master-control valves.

- a. A master-control gate valve is required for each user's property for emergency purposes so that water can be shut off from the District's line in case of leaks. etc.
- b. Whenever District personnel find that there is no master-control valve for a connection, one must be installed by the water user or plumber, subject to District inspection. Estimates for District installation may be obtained from the District.
- c. Maintenance and replacement of master-control valves are the responsibility of the water user.

5. Connection fees and authorized connections to district lines:

- a. Before any connection is made for the use of District water or to any District line, it is necessary that an "Application for Service and Connection permit" be obtained.
- b. Taps to District lines will be made by District Personnel only.
- c. The District will allow one connection per lot. The size of the valve will be determined by the District according to lot size and pressure available.
- d. Any unauthorized connection will be disconnected until the connection fee, impact fee, and or other fees have been paid. The District, for re-establishing service, will also charge a fee of \$500.
- e. No cross connections will be allowed between District and other water lines.
- f. It is illegal to extend Pine View water lines into any buildings or lay them in the same trench as culinary water lines.

6. For the wasteful use of water, or the failure to comply with these regulations, the district may:

- a. Cut off the water service and charge \$500 to re-establish service. Re-connection will be made only by authorized representatives of the South Ogden Conservation District or the Weber-Box Elder Conservation District.

7. Amendment and changes to rules and regulations.

- a. These rules and regulations may be amended and changed at any time by the Board to more equitable and fairly distribute the water available to maintain its beneficial use. Emergency and special time of use of water may be required; in this event notice will be given.

Violators of the above rules will be subject to the penalties above provided. Every attempt will be made by the South Ogden Conservation District and the Weber-Box Elder Conservation District to help correct misunderstandings that might exist before water is turned off.
